PROBABLE CAUSE

On 3/21/2013 at approximately 3:46 A.M I, Trooper Javon Murphy, was dispatched to a single vehicle crash in the area of NE 21st Street and NE 156th Avenue. I arrived at the scene at approximately 4:06 AM. Deputies from the Alachua County Sheriff's Office were on scene when I arrived. I was advised by the Alachua County Sheriff's Office that the crash occurred at approximately 2:20 AM. I then observed a silver Honda Civic at final rest on the south shoulder of NE 156th Ave. The vehicle displayed major damages to its front and all its tires were deflated. The physical evidence indicated that the vehicle struck a ditch and a FDOT sign on the south shoulder of NE 21st Street and NE 156th Avenue. Deputies advised that they observed the driver, STUART CRAIG LOWE, behind the driver's seat when they arrived on scene. They further advised that Mr. Lowe appeared to be intoxicated. I made contact with Mr. Lowe and I identified him by his Florida driver's license. Mr. Lowe advised that he fell asleep prior to the collision, which resulted in the crash. I asked Mr. Lowe if he had on his seatbelt and he replied, "yes." I then noticed that Mr. Lowe had a red seatbelt mark across his chest which placed him in the driver's seat at the time of the crash. I immediately began to smell a strong odor of an alcoholic beverage emitting from Mr. Lowe's breath as he spoke. Mr. Lowe's eyes were bloodshot and he was unsteady on his feet. Based on my observations, I transitioned to a criminal investigation of DUI. I read Mr. Lowe the Miranda Warning immediately after and he admitted to being the driver of the vehicle during the crash. Mr. Lowe continued to advise that he had fallen asleep. Mr. Lowe admitted to having consumed "three beers" earlier that night. He said that his last alcoholic beverage was consumed at approximately 10 PM. I then requested Mr. Lowe to perform several Standardized Field Sobriety Exercises (SFSEs). The SFSEs performed were the Walk and Turn, the One Leg Stand, the Finger to Nose, and the HGN. Mr. Lowe performed poorly on the SFSEs. Mr. Lowe was arrested at approximately 4:58 A.M for DUI. Mr. Lowe was transported to the Alachua County Jail, and he stated that he did not consume any alcoholic beverages after the crash. When we arrived at the jail, Mr. Lowe was offered a breath test. Mr. Lowe submitted to the breath test and he blew a .069 and a .081. Due to the time lapse between the crash and the time of the breath test (approximately 4 hours), I concluded that Mr. Lowe's BAC was above a .08 at the time of the crash. Mr. Lowe was booked into the Alachua County Jail for DUI property damage.
