police. The noises she heard were consistent with the acorns on her deck crunching as someone walked on them.

Officers were set in a perimeter about the residence within 60-90 seconds of receiving the call. We were in the process of clearing it when at 0557hrs defendant was seen moving west in the yards across the street. Defendant was naked except for a skull cap and running shoes. Defendant was challenged by LEO at which time defendant ran south through the yard, then south on NE 5th Ter. Defendant was ordered to stop but continued to run south then west into the yard at 718 NE 5th Tr. A new perimeter was set and defendant was located leaving a yard near 500 NE Boulevard. Defendant was again ordered to stop and again ran north until he was met and detained by a taser deployment. Defendant invoked his rights and hence did not dispel LEO's fear that he had committed or was about to commit a burglary.
