his iPad. The defendant picked up the iPad, concealed it in an envelope he was carrying, and proceeded to exit the building. This theft was captured on the police department's CCTV surveillance camera.
The defendant returned to the police department a short time later. His girlfriend alerted him that we were (police) looking for him, and he left. The defendant was contacted as he was trying to flee in his vehicle.
As he was being arrested, the defendant spontaneously stated he was leaving to go retrieve the iPad and return it to the police department.
Post-Miranda, the defendant agreed to take us to the iPad. The defendant directed us to 1114 NW 6th St, an apartment complex. The defendant had concealed the iPad under neath cinder blocks. Affiant retrieved the iPad.
