Probable Cause

On this date, a white male positively identified as William Kyle Rossignol (04/06/85) entered into the CAMPUS USA Credit Union @ UF Health Center and attempted to rob the business. Video footage corroborates the actions of Rossignol as reported by the victim and a witness. The victim, who is an employee of the credit union, reported the white male came to her counter and placed a hand written note on it. The note indicated the subject wanted money and he was armed. The victim said the subject told her he was not playing and he would shoot her, at which time, he displayed the butt of a black semi-automatic handgun. The victim did not have immediate access to any cash and when the subject discovered that to be the case, he picked up the note from the counter and left the business. The victim was fearful of the subject being armed and reasonably believed the subject intended to commit the bank robbery. The victim positively identified Rossignol from photos shown to her by GPD Det. Randy Roberts. This crime occurred on the University of Florida campus, in the City of Gainesville, Alachua County, Florida. Rossignol took flight from the scene of the crime. He was pursued by law enforcement during which time he discarded personal items from the car. The items inside the backpack contained his wallet, the clothes worn during this crime and an air soft gun. Post Miranda, Rossignol admitted to this crime and discarding his backpack. He said personal items were in the backpack to include clothes, his wallet and an air soft gun.
