In the Circuit Court of the Eighth Judicial Circuit of the State of Florida, for Alachua County, at the Spring term, thereof, 2017.

THE GRAND JURORS OF THE STATE OF FLORIDA, enquiring in and for the body of the County of Alachua, upon their oaths present that FRANCIS RAYMOND PALAZZI SR, in Alachua County, Florida, on or about December 31, 1994, did with a premeditated design to effect the death of JAMAL MCGOWAN, a human being, unlawfully kill JAMAL MCGOWAN by shooting him with a firearm, and the act was perpetrated from a premeditated design to effect the death of JAMAL MCGOWAN, and during the course of the event FRANCIS RAYMOND PALAZZI SR did carry on his person and discharge a firearm resulting in the death of JAMAL MCGOWAN, contrary to Sections 782.04(1)(a)(1) & 775.087, Florida Statutes. 
